

- Removal of existing windows, starting on level 8.
- Establishment of temporary mechanical & electrical services.
- Scaffolding works ongoing
- Structural alteration works have commenced
- Completion of façade clean and repairs ongoing

#### **Next 12 Weeks Works Schedule:**

- Structural builders work are ongoing
- Structural works ongoing
- Window removal and installation ongoing.
- Continuation of façade repairs.
- Commencement of internal fit out 1st fix
- Relocation of site offices and welfare to south elevation.
