## **Brettenham House**



## Dear Neighbours,

It's with great pride that McLaren are now the principal contractor for the refurbishment of the Brettenham House project in Savoy Street. We are fully committed to working and engaging with our residents and businesses within the community.

## **Brettenham House History**

Occupying an excellent location, with a long history of providing compassionate care, the Brettenham House office structure is an example of Art Deco architecture built in the early 1930s. The land once contained a hospital licensed in 1512 and until recently was occupied by the Royal Humane Society. First established in 1774 and at a period when the river Thames banks reached far wider, the Royal Humane Society were ideally situated. With George III's backing the Society, originally named the Society for the Recovery of Persons Apparently Drowned, became Royal in 1787. Elements of the hospital remain today with the original chapel walls, dedicated to St. John the Baptist, being incorporated into the current chapel. Principal Contractor: McLaren mclarengroup.com

- Demolition works are near completion
- Continuation of façade repairs and cleaning.
- Removal of existing windows, starting on level 8.
- Establishment of temporary mechanical & electrical services.
- Scaffolding works ongoing
- Structural alteration works have commenced
- Completion of façade clean and repairs ongoing
- Removal of archives complete

### Next 12 Weeks Works Schedule:

- Completion of scaffold including temporary roof.
- Completion of demolition.
- Structural works ongoing
- Window removal and installation ongoing.
- Continuation of façade repairs.
- Relocation of site offices and welfare to south elevation.
